American Rottweiler Club Judges Education Presenter Policy

Approved by ARC Board of Directors 6/12/14

What is a Presenter?

A Presenter is a person that has breed knowledge acquired by years in the breed long enough to have established a reputation. They must have been breeding their own line for at least three generations to know the genetic weaknesses in the breed. Their dogs should not only excel in the show ring, but should have done some work in whatever field for which the breed was created. They will travel to present our standard to groups of judge applicants in a classroom environment.

Presenter criteria

A Presenter must be a member in good standing with the American Rottweiler Club. Presenter must be available to allocate the time, be comfortable speaking one-on-one or in groups ringside evaluating dogs with judge applicants. Presenter receive no reimbursement from the ARC.A list of ARC Approved Presenter, by state, is available from the Judges Education Coordinator and submitted to AKC for issuance to seminar attendees. If a Presenters ARC membership should lapse, the Presenter will be removed from the list. Presenters must be available to allocate the time, be comfortable with public speaking, able to learn computer skills necessary to perform a presentation, and have the energy and enthusiasm to conduct a seminar. The Judge's Education Seminar will be presented in a collegial atmosphere.

A Presenter must meet the following criteria:

Be an AKC licensed judge, with the Rottweiler as first breed

OR

Been involved in the breed for a minimum of 12 years experience breeding, handling, exhibiting in conformation and performance events AND have met at least 25% of the requirements under the AKC "12-5-4 Method" * for becoming an AKC licensed Rottweiler judge.

OR

Been involved in the breed for a minimum of 15 years experience breeding, handling, exhibiting in conformation and performance events AND have met at least 1 of the 4 required components under the AKC "New Breed Alternate Method" * for becoming an AKC licensed Rottweiler judge.

AND

Have attended at least one ARC Judges Education Seminar.

AND

Have viewed the ARC Mentor/Presenter Training PowerPoint Presentation on the ARC Judges Education website: www.americanrottweilerclubjudgeseducation.com

In order to remain on the ARC Presenters List, it is suggested that a presenter attend the Judges Education Seminar at the ARC National Specialty or any ARC Judges Education Seminar at least once in every 5 years. Also, if a presenter's ARC membership should lapse, the presenter will be removed from the list.

Guidelines for Presenter

- This is training for judges in a class format. A collegiate atmosphere of tutoring is required.
- Stick to the approved standard without personal preferences.
- Use only the tools provided by the American Rottweiler Club.
- Know the Rottweiler Standard and the commentary in the Illustrated Standard.
- Use only positive aspects of dogs during discussions. AKC encourages trainers NOT to discuss any aspect of a dog's failure to comply with the standard. Try to point out a dog with correct aspects, if one is in the ring.
- · Refrain from discussing pedigrees, wins, or show records, registered names, titles or boasting of a dog's

capabilities. A competent judge has had enough dogs stuffed under their nose as 'the Presenter perfect dog'. This will only lend to invalidating anything you teach.

- Do not use profanity. You are a representative of the American Rottweiler Club.
- If a judge asks if there is too much of this or that on a dog, please try to be patient and point out a better this or that on another animal, decline to comment on traits you don't like in that dog, or just be kind in how you indicate that the dog may be lacking adherence to the standard.
- Stay abreast of the FAQ page and 'walk-the-talk' of the parent club on sensitive issues.
