## **Requirements**

- Applicant must have a minimum of 10 years documented involvement with the Rottweiler.
- Applicant must have judged a minimum of 2 matches, either all-breed or Rottweiler, with at least 15 entries each to be approved to judge a <u>Regional Sweepstakes</u>; 4 matches to be approved to judge a <u>National Sweepstakes</u>.
- Must have a minimum of 25 points total from A, B, C and D; and no more than 5 points from E and F.
- Must have attended a Rottweiler Judges Breed Seminar.
- Minimum of 30 total points to be approved to judge a <u>Regional Sweepstakes</u>.
- Minimum of 45 total points to be approved to judge a National Sweepstakes.
- Applicants must attach documentation for all points checked.
